

## Copper Mountain Parking Plan - FY25

## Copper Employee/Volunteer Parking

- **EDGE Residents:** Elevation Lot (parking lot to the east of Lodging Check-in) is reserved for EDGE Residents with an eligible parking pass for that lot.
  - EDGE Residents will receive an Elevation Lot parking pass upon registering their cars with the employee housing office
  - Each Tuesday evening, EDGE residents will need to move their cars from the Elevation Lot to Chapel Lot to allow for plowing
  - Each Wednesday, EDGE residents will need to move their cars from the Chapel Lot to the Elevation Lot after plowing
  - Guest passes are available through employee housing office for Alpine Lot
- **Sky Chutes Residents:** Sky Chutes Lot (parking is dispersed around the Sky Chutes apartments) is reserved for Sky Chutes Residents with an eligible parking pass for that lot.
  - Sky Chutes Residents will receive a Sky Chutes Lot parking pass upon registering their cars with the employee housing office
  - Guest passes are available through employee housing office
  - Effective FY25 Sky Chutes residents will not receive a Powder Lot parking pass, they will only be issued a Sky Chutes parking pass
  - For employees that need to be at work before/after shuttles are running please coordinate with your respective RLT member
  - Guest passes are available through employee housing office for Alpine Lot

## All other Copper Mountain Employees/Volunteers:

- Active employees/volunteers will receive a Powder Lot parking permit sticker upon registering their cars with the Employee Experience office.
- Employees/Volunteers will receive one parking sticker that will allow one vehicle access to Powder Lot; if additional parking is needed for other cars – those will need to be parked in Alpine/Far East Lots. Sticker must be adhered to registered vehicle's window.
- Powder Lot (parking lot to the west of Lodging Check-in) is reserved for Employees/Volunteers who are working that day with an eligible parking pass for that lot.
   Space is as available, first-come, first-served; a parking lot attendant will be present.
- o Alpine Lot/Far East Lot are overflow for Powder Lot when full.
- Overnight parking/camping/sleeping in vehicles is not allowed on any Copper property
- No personal vehicles of any kind are to be parked inside of the villages; park in designated parking spaces only to maintain access/egress for emergency vehicles and to respect our pedestrian village.
- For employees that need to be at work before/after shuttles are running please coordinate with your respective RLT member.

## • Copper Mountain Merchants (VAC, Metro, Merchants)

 Each merchant will receive 2 hanging parking tags with access to Powder Lot (overflow Alpine/Far East Lot) for employees working that day. Merchants will manage access to their parking tags; we are unable to recreate if lost/stolen.

•	<ul> <li>Violations – Parking unauthorized vehicles and/or parking in undesignated spaces may result in tickets, fines, and/or towing and may also result in loss of parking privileges. Employees may face disciplinary action up to termination of employment for multiple violations.</li> <li>Parking passes/hang tags are not to be shared with any friends/family, etc.; they are for designated individuals to use while working.</li> <li>Powder lot is not to be used while skiing/riding on days off – it is designated for employees who are working that day.</li> </ul>
